PELL (www.fafsa.ed.gov) codes are provided upon applying for the FAFSA/PELL grant. PELL must be applied for per the local policy of the Pasco-Hernando Workforce Board (Region 16). Applying for the PELL may give you additional funds for training; this is a grant and not that of a loan. This means if you are awarded you do not have to pay the PELL Grant back.

Please note that if you are awarded the Federal PELL grant in any amount of those funds will be applied first before the award of the financial assistance of the WIOA program.

All Public schools based on the course and clock hours of that training being provided are PELL eligible. If the course of choice does not meet the PELL clock hour requirements, the course is not PELL eligible.

Most individuals whom have a Bachelor's Degree are not PELL eligible but must obtain a statement from the provider indicating this.

If the provider above is Not PELL Eligible, you must obtain a statement from the provider indicating they are not PELL Eligible; this will satisfy the policy requirement of applying for the PELL.
